**History**

Governor E. Benjamin Nelson, by Executive Order 91-1, created the Nebraska Rural Development Commission in January 1991. Legislative Bill 190, passed by the Nebraska Legislature in May, 1993 codified the Commission as a non-code state agency and linked it administratively with the Nebraska Department of Economic Development. Recognizing that the Commission has a mission and purpose broader than just economic development, the Legislature passed LB 1053 in April, 1998 to remove the administrative link with the Department of Economic Development.

**Mission**

The purpose of the Commission shall be to foster sustainable community and economic development initiatives. These initiatives should enable Nebraska communities to realize their own goals, thereby contributing to the growth and well-being of the entire state.

**National Rural Development Partnership**

The Commission is affiliated with the National Rural Development Partnership (NRDP). NRDP is a national partnership of states and the national government to support effective development throughout rural America.

**Rural News Bits**

The result of a cooperative arrangement between several organizations devoted to rural development, Rural News Bits is a monthly newsletter which has replaced the Commission's Rural Partners newsletter. Anyone can receive Rural News Bits by contacting the Commission's office.

# 1999 TOP 10 Rural Development Initiatives

## **Introduction**

The Nebraska Rural Development Commission is honored to recognize the 1999 Top 10 Rural Development Initiatives. These are the ten development initiatives selected by the Commission for special recognition as examples of outstanding rural development activity (in alphabetical order). There are a great number of worthy initiatives and projects that are not recognized on this year's list. The Commission would like to salute all those groups and individuals who continue to build better communities in rural Nebraska.

## **Ainsworth Middle School Nature Trail Project**

Two years ago, instructors at Ainsworth Middle School began an ambitious integrated project within their classes to construct a hiking trail. The students surveyed an area near Pine Creek, they built steps and bridges, widened a pathway through the canyon, and covered the trail with wood chips. Sixty-five students, along with teachers from different disciplines, helped with the project. A total of 3,000 students and 200 school staff hours went into the project. Other organizations and businesses also assisted with the construction of the trail. Permanent signs, benches, picnic tables, and additional stairway improvements are currently being constructed. The entire project has created a sense of pride among the students and provided a much appreciated nature trail experience for individuals visiting the park. Contact Marjorie Wilkins, 402.387.2082.

## **Ainsworth Project World Series**

Regional collaboration was the key to Ainsworth's success in bringing Advantage Receivable Solutions to Ainsworth. Advantage Receivable Solutions is an accounts receivable company for the telecommunications, health care and financial services industries. The regional collaboration project, called the "Ainsworth Project World Series" was a success due to the collective energy supplied by the many organizations involved in the group, as well as the many volunteers and businesses. ## **Box Butte General Hospital, Alliance**

Over the past four years, the Box Butte General Hospital has conducted a "listening" campaign. The philosophy of the hospital administration was to listen to the public and respond to their needs. As a result, three new programs were started that addressed the community's needs. The "Ailing Angels" program was developed to provide an alternative for working parents who have sick children between the ages of 3 months to 18 years. "A Women's Heart" conference was held to offer an overview of heart disease specific to women and its prevention. Finally, a partnership between the Hospital and the Cow Country Community Foundation was reached that provides for a fully staffed medical clinic in Hyannis and the surrounding rural area. ## **Buffalo Commons Storytelling Festival, McCook**

The Buffalo Commons Storytelling Festival, held the first weekend after Memorial Day, drew visitors from across the Southwest Nebraska area and beyond. Local storytellers, as well as those from other areas of the state and nation provided for the "storytelling" entertainment. The 1999 Festival theme, "The American Experience", brought together many generations to share their stories, including those at the Kids Fest. The storytellers had varied backgrounds and histories, they have may be railroaders, veterans, Native Americans, settlers, cowboys, historians, humorists, farmers or someone who just wanted to tell a story. # 1999 TOP 10 Rural Development Initiatives

## **Pawnee City Downtown Improvement Project**

One of the public recommendations made during the 1996 Nebraska Tourism Industry Development Plan was to “complete the physical redevelopment of Pawnee City’s historic downtown district.” Work began in the fall of 1998 and within a year, the revitalization of the Historic District in downtown Pawnee City was completed. The downtown project consisted of a six-block area. This area received new streets, sewer lines and sidewalks with handicap accessibility. Additionally, through the many individual donations, Victorian lights were once again placed around the Courthouse square and in the downtown area. Pawnee City has forty-eight of the fifty-six commercial buildings in this district listed on the National Historic Register, including the Pawnee County Courthouse. Contact L. ## **Southwest Nebraska Dairy Development Partnership, Palisade**

The Southwest Nebraska Dairy Development Partnership was formed to attract new dairy operations to the southwest region and to provide for value-added agricultural and employment opportunities. The Partnership, which includes power districts, financial institutions, economic development groups, pooled their resources to conduct activities such as participating in farm shows, direct mailings, development of promotional materials, follow-up contacts, and hosting visiting dairy operators. ## **Steamboat Trace Hiking/Biking Trail**

After nearly five years of planning and design, the Steamboat Trace Hiking/Biking Trail is now open throughout its total 21-mile corridor. October 1998 saw the opening of the southern half from Peru to Brownville. One year later, the northern half, from Peru to Minersville, south of Nebraska City, was dedicated. The total project costs was approximately \$1 million dollars. Steamboat Trail is a testimony of the power of partnering. While the owner and manager of the trail is the Nemaha Natural Resources District, many other organizations and agencies contributed to its success, including Boy Scout troops and volunteers who spent over 2,000 hours on bridge decking and clearing debris. The Steamboat Trace Association coordinated many of these volunteer activities and raised over \$20,000 in local contributions for construction and promotion. Another local group, the Peru Depot Gandies, was instrumental in the development trail facilities at Peru, including picnic and parking area, guidebooks, and trailhead markers. ## **Valley County Historical Society, Ord**

During the 1999 Labor Day weekend, the citizens of Ord stepped back in time with special events sponsored by the Valley County Historical Society. A Cotillion was held at Fort Hartsuff, to aid in their celebration of their 125th Anniversary. The Cotillion was an opportunity for people of all ages to dress in costume, ranging from the Victorian to the Bobby Sox eras. Even students from the University of Nebraska at Omaha used the historical event to conduct research and participate in the Cotillion wearing period clothing. An old-fashion riverside church service was held at Anderson Island and the weekend ended with a vintage baseball game between the Ord Tiger team and the Railroad Town Rowdies from the Stuhr Museum. ## **Village of Johnstown**

Johnstown, a small North Central Nebraska community, is doing great things with so few people...“about 48” according to the nomination. Johnstown is a community with a lot of heart and a determination to keep their community alive. Projects for 1999 included renovation of the old fire hall for the village office, replacement of sidewalks, and general repairs and painting of town buildings. Johnstown was also host to the Brown County Fair, which featured two Top 10 Country music stars. The new community center served as the gathering spot for the community’s Country BBQs and dances. Also in 1999, nine homes were renovated through a special housing grant with Woodlake, Cody and Nezel. ## **Village of Petersburg**

The community of Petersburg came together in 1999 to revitalize and beautify their community of 388 people. Projects completed during 1999 included the construction of community welcome signs; expansion of the Petersburg’s Locker to specialty meats and sponsorship of the 17<sup>th</sup> annual Nebraska State Antique Tractor and Horse Plowing Bee. The Bee was a special event that brought together children and senior citizens alike for a day of fun and activity. Other events included a drive to keep the Petersburg Public School open, fundraising efforts for the volunteer fire department and EMT’s, a pancake brunch for Rural Friendship Day, and the formation of a new youth group. ### **Bayard Chimney Rock Museum**

On June 1, 1999, the Chimney Rock Museum in Bayard opened in the old Burlington Northern depot, which was destined for demolition. The museum displays items from Bayard's past, including antique farm equipment, tools, clothing, photographs, and family histories shown on quilt blocks. ### **Buzzword, Morrill**

The Buzzword, published monthly by the Morrill High School Journalism class, was started to improve the communication of local news items in the communities of Morrill, Henry and Lyman. The monthly newspaper was started with funds from the School at the Center project and is freely distributed in all three communities. ### **Cattleman's Ball, Lexington**

Billed as one of the premier events in Nebraska, the Cattleman's Ball annually raises monies for the Eppley Cancer Research Center in Omaha and community medical services. The 1999 event was held at the Robb Ranch, near Lexington. Approximately 3000 people attended the one day event and donated \$175,000. Ten percent of the donations were dedicated to the Emergency Medical Services of Lexington and Johnson Lake, development of an outdoor recreational complex, and the Oncology Program at Tri-County Hospital.

### **Chadron YouthBuild Program**

The Chadron YouthBuild Program was the first rural YouthBuild Program to be funded by the U.S. Department of Housing and Urban Development. The Program, which is an educational, leadership development and job-training program, began in 1999. Ten participants, ranging in age from 15 to 24, completed rehabilitation of two homes in Chadron for low to moderate income families. Contact Marguerite Vey Miller, 308.432.4346.

### **City of Chadron**

Promotion of tourism and economic development was one of the key activities for the City of Chadron in 1999. Tourism highlights included the Museum of the Fur Trade, Fur Trade Days in July, the Annual Spring Quilt Show, the Mari Sandoz Heritage Room at Chadron State College, and mountain biking in the Pine Ridge. ### **EDGE Youth Project, Kimball**

The EDGE (Education, Diversity, Goals, and Entertainment) Youth Center plays a key role in the lives of Kimball's youth. The Youth Center provides area students a place for games, activities, dances, and educational opportunities using the Center's computers and tutoring options. A Bike Club was also created for old bike donations and repairs. Adults volunteer their time at the Center and provide a valuable mentoring program to Kimball's youth. ### **Lincoln House Apartments, Scottsbluff**

The former Lincoln Hotel, built in 1918 in Scottsbluff, was once the "grand hotel" of the Panhandle. The tallest building in Scottsbluff, the Lincoln Hotel sat vacant since 1983 and was destined for demolition. Thanks to the work of many individuals and investors, the grand hotel is again open for business as an elegant, affordable 35-unit housing complex for the elderly. ### **Monument Valley Pathways Project, Scottsbluff**

In 1990, the non-profit Monument Valley Pathways Project developed a plan for the building of a pathway along the scenic North Platte River which would tie together the major recreational facilities in Scottsbluff. Each year the pathway project continues to advance towards its goal of a completed 26-mile long path that reaches Scotts Bluff National Monument and circles back to the beginning of the path along the North Platte River. **National Antique Tractor Pull Championship, Ogallala**

The National Antique Tractor Pull Championship began in 1998 to promote economic activity within Ogallala and the surrounding area. The Tractor Pull, a two-day event, is held indoors in December. The first day consists of the National/Regional Antique Tractor Pull with the State of Nebraska Antique Tractor Pull on the following day. **Oregon Trail Days, Gering**

The 79<sup>th</sup> annual Oregon Trail Days was a four-day extravaganza that drew more than 30,000 people to Gering Nebraska. The Oregon Trail Days is often referred to as Nebraska’s oldest continuing celebration. More 800 volunteers worked to make this event one to remember. Activities at the Trail Days included an Old Settlers two-day reunion, parades, barbecues, street dances, concerts, International food fair, melodramas, and the state championship CASI chili cook-off. **Panhandle Partnership for Health and Human Services**

The Panhandle Partnership is an excellent example of agencies and communities working together to meet a common goal—the betterment of the health and well-being of its citizens. Accomplishments of the Partnership include a Children’s Outreach Program, collaborative relationships with the Native American community and support of the Border Tiospaye, combined resources for community planning in 11 counties, and promotion of health insurance for rural families through the Robert Wood Johnson Connecting Kids Project. **Panhandle South Museum Alliance**

A group of ten museums and attractions in the Panhandle are working together to increase visitation and awareness of the different activities in the area. The Alliance created brochures, maps, discount cards, and many other helpful items for promoting area attractions. Members of the Alliance donated their expertise and time to help other members. **Partners Hay Marketing Cooperative, Kimball**

Through the efforts of the PARTNERS Project, Kimball area alfalfa producers and business owners worked together to create the area's first hay marketing cooperative. Incorporated in 1999, the cooperative has since found markets for its members’ alfalfa, arranged for testing of each cutting, and coordinated the transportation of all alfalfa sold. **Renaissance Project, Kimball**

Now in its fourth year, the Kimball Renaissance Project continues to target community leadership development for adults and youth alike. Youth activities include mentoring programs, Junior Achievement, Celebrate the Panhandle, community volunteerism, and Youth Empowerment. Community enhancements include arts and humanities activities, Nebraska Community Improvement Program projects and Lied Mainstreet membership. **Sheridan County Community Builders Housing Initiative**

The Sheridan County Housing Initiative started in 1999 in response to an area shortage of skilled construction labor and the need to educate young people about the opportunities that exist for careers and employment. Funded through a grant from Nebraska Department of Economic Development’s Partnership for Economic Development Act, the Initiative subsidized the wages of youth workers hired by contractors working in Sheridan County. **Arthur County Students in Action**

Youth involvement in community activities is crucial to the welfare of a small community. Just ask anyone in the small community of Arthur. **Ogallala Main Street**

Promotion of Ogallala's downtown business district was a little more challenging last year due to major road construction. ### **Nelson Institute, McCook**

The Nelson Institute was created in 1998 by Former Governor Ben Nelson. The goals of the Nelson Institute are to support efforts which promote understanding and development of unity, creation of an endowment which will eventually fund an “Innovation Grants Program” to provide seed grants for projects in leadership development, economic development, community collaboration and community mentoring; and support the creation of a program to retain our youth by training them in the value of building communities through the Nelson Fellows Program. ### **Sehnert’s Bakery and Bieroc Cafe, McCook**
